CONDITIONS OF PARTICIPATION

**PAYMENT** – Full payment to be received with application. Make checks payable to OABA and remit to Nora Custer, OABA Vendor Coordinator, Custer's Alpacas, 744 Clyde St, Akron, OH 44310

**PARKING** – vehicles to be parked in designated areas. Parking is plentiful.

**TAXES** – Ohio sales tax applies. Vendor is responsible for all sales taxes and tax licenses.

**USE OF SPACE** – AlpacaFest Show Coordinators and Ohio Expo Center reserves the right to review and/or restrict any display or materials. All Exhibits/displays must be contained within the Vendor space assigned. Special requests must be made in advance by contacting AlpacaFest Show Coordinator.

**CLEANING & STORAGE OF MATERIALS** – Vendors are responsible for keeping their display/booth area clean and orderly. Vendors are responsible for removal of all items, including trash, from their space at the conclusion of the show.

**CANCELLATION OF ALPACAFEST** – If AlpacaFest 2009 is not held, this contract shall be deemed terminated and OABA shall make full refund of all charges paid by the Vendor.

**OTHER** – All other matters not specifically covered by these rules/regulations shall be subject to the sole discretion of OABA;

**LIABILITY AND INSURANCE** – Vendor is solely responsible for his/her own property. Ohio Alpaca Breeders Association, Ohio Expo Center, the State of Ohio, or any of their employees, agents, contractors, officers or directors are not responsible for any damage to or loss of any property of the Vendor.
